Why the Global Economy is Relevant for the Students?

"When today's students enter the world of work, they will be working with the world itself. As the UN states, they will 'work for international companies, be involved in international trade; collaborate with peers around the world on multinational ventures; tackle global problems (such as disasters, disease, and climate change); collaborate with employees from a variety of cultures; and compete with peers around the world for jobs and markets." (OECD, 2018)











Preparing Students for a Career in the Global Economy

Essentially steer education towards preparing students to compete successfully in the global economy.

The push to educate students for the twenty-first century more specifically refers to equipping students with the knowledge, skills and sensitivities to compete and navigate the challenges caused by globalization in the twenty-first century.

A survey of current frameworks and policies propagated by transnational organizations such as the Organisation for Economic Co-operation and Development (OECD) as well as those emerging from the USA and Singapore, reveals that twenty-first-century education is primarily focused on one aspect of globalization, namely, economic globalization, to the exclusion of political and ethical dimensions of globalization.
